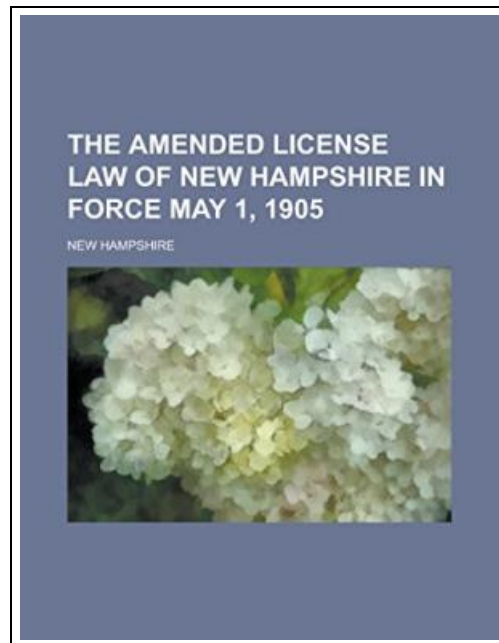

If a witness so summoned fails to appear or to give testimony in accordance with the summons, any justice of the Superior Court, in term time or vacation, upon application of said board shall compel the witness to attend before said board and testify, as if he had been duly summoned to testify before said court in an action there pending (s. 35). 8.
