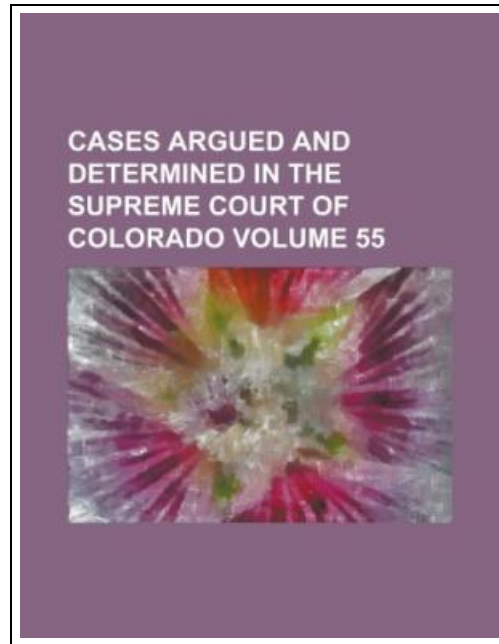

Excerpt: . . . for defendant in error, quoted in the opinion, that such evidence be considered in the record does not, in my judgment, foreclose the question as to whether the county would or would not have purchased the land if the offer to sell had not been withdrawn.
