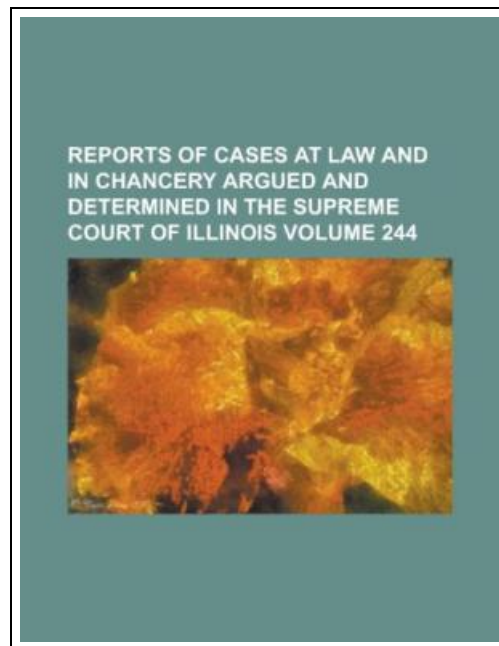

Excerpt: . . . amenable to the provisions of the act which shall neglect or fail to comply with any of the provisions thereof, and further provides that in addition to such penalty, if after this act shall take effect, any foreign corporation shall fail to comply herewith, no suit may be maintained either at law or in equity upon any claim, legal or equitable, whether arising out of contract or tort in any court in this State. Appellant contends that a foreign corporation must comply with the provisions of this statute before it can institute or maintain a suit in any court of this State, because the bringing of a suit is in itself doing business within the meaning of the statute, and is the exercise of one of the corporate powers of the corporation. The words doing business and transacting business, as used in statutes regulating foreign corporations, have by numerous judicial decisions been given a settled and recognized meaning, and refer only to the transaction of the ordinary business in which the corporation is engaged, and do not include acts not constituting any part of its ordinary business, such as instituting and prosecuting actions in courts.
